Reservations and Payments: Prices are based on double occupancy. A deposit of \$1000 per guest is required to reserve your space. A second payment of \$1000 is due June 1, 2023. Balance due July 1, 2023. Credit card payments are subject to a 3% surcharge. Reservation deadline is June 1, 2023. Limited availability.

Hotels: Accommodations in a 3 or 4 star hotel. All rooms are with private bath.

Baggage: One suitcase per person is strongly encouraged. The organizers of the tour accept no liability for loss or damage to luggage, although maximum care will be taken to insure safe handling of your luggage. Baggage fees are subject to individual airlines.

Cancellations: All cancellations must be received in writing. LUXEMBOURG ADVENTURES highly recommends travel insurance. No exceptions will be made to the cancellation policy for any reason.

Any substitutions will be within the original category.

Value Holidays and LUXEMBOURG ADVENTURES are not liable for defaults of other firms or agencies. Baggage is at owner's risk at all times.
